



2021 MINOR WAIVERS REQUIRED FOR ALL MINOR PARTICIPANTS & ATTENDEES

Our insurance requires original signed and notarized waivers for both tracks to be completed for ALL MINORS ATTENDING OR PARTICIPATING in any NHKA Racing Series events in 2021. NHMS also has a minor waiver of its own that their insurance requires. Fortunately these forms only need to be completed once a year, but they need to be redone every year. In an effort to streamline the process, the carriers are allowing us to distribute blank forms electronically. However, you MUST still return signed and notarized original forms to the NHKA as instructed below:

1. Print one copy of this PDF for each minor who will participate in or attend an NHKA event in 2021. This will result in three similar looking 2-page forms (six form pages total) for each minor:
 - Two pages for NHKA/KEI – Canaan Motor Club
 - Two pages for NHKA/KEI – New Hampshire Motor Speedway
 - Two pages for New Hampshire Motor Speedway

Printouts of blank forms must clear and fully legible. Full color is preferred but not required.

2. STOP! The signing of these forms must be witnessed by a notary and certified with their raised seal. Notary services are available at most banks and law offices for a fee.

3. NHKA/KEI forms for both tracks:

PAGE 1: Parent is to sign and print name, date and add name and age of minor. Blue ink is preferred. Notary is to witness and apply a raised seal in the area of the witness signature.

PAGE 2: Minor is to sign and print name, date and indicate their age. Blue ink is preferred. Notary is to witness and apply a raised seal in the area of the witness signature.

4. New Hampshire Motor Speedway form:

PAGE 1: NHMS insurance requires both parents sign and print name, date and add name and age of minor. Blue ink is preferred. (If minor is a member of a single-parent household, it is suggested you bring documents to notary showing sole custody status.) Notary is to witness and apply a raised seal in the area of the witness signature.

PAGE 2: Minor is to sign and print name, date and indicate their age, as well as add date of signing near top. Blue ink is preferred. Notary is to witness and apply a raised seal in the area of the witness signature.

I HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE, AND DISCHARGE, ALL OF THE RELEASEES FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin, for any and all loss or damage and any claim or any demand on account of any injury to me including, but not limited to, my death, whether caused by the **NEGLIGENCE** of the Releasees or otherwise.
